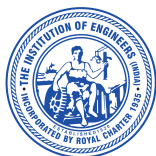

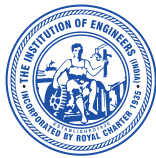

2.0 Eligibility Guidelines for the Fellow Membership (FIE)

- Age: Minimum 40 years on the date of application and
- Educational Qualification: B.E/B.Tech/M.Tech or Section A&B Examination of IEI or equivalent qualification recognized by the Institution shall be accepted for various classes of membership. Other qualification may be accepted in consultation with the Equivalence Committee and
- Experience: A total post qualification experience of atleast 15 years and above and holding a position of high responsibility in the following manner:-

'Position of High Responsibility' for:-

- Applicants from Indian Army/ Navy / Air Force/ Paramilitary Force in the rank of Lt Col or above in Indian Army and equivalent posts in Indian Navy / Air Force/Paramilitary Force.
- Applicants working/worked in PSUs in India at a Senior Managerial position .
- Applicants working/worked in CSIR or other Govt research Laboratories/ Institutions should be at the grade of Scientist E or above.
- Applicants working/worked in other Central / State Government organizations at the rank of Superintending Engineer or above or
Executive Engineers with a total post-qualification experience of 20 years shall be deemed to have held a position of High Responsibility and shall be eligible for Fellow (FIE).
- Professors/ Associate Professors working/ worked in Universities/ Degree Colleges should draw the salary as per UGC/AICTE norms.
- Applicants working/worked as Principal/Head of the Department (drawing the pay scale of Principal) in a Polytechnic.

VII) Self Employed applicants for Fellow (FIE) may be classified into two categories:

- Those who own organizational setups
- Individual Practitioners e.g. Consultants/ Surveyors/ Valuers/ Loss Assessors etc.,

'Position of High Responsibility' for:-

- (A) Self Employed applicants who own organizational setups providing Engineering products/ services should satisfy that
- (i) Best of the last 3 years annual turnover as reflected in the certificate by Chartered Accountant or IT Returns should be Rs.2 crores or above along with the documents on Company registration and other relevant papers etc.
- (ii) Minimum age of the organization should be 10 years.
- (B) Individual Practitioners (e.g. Consultants/ Owner of Consulting Company under sole proprietorship/ Surveyors/ Valuers/ Loss Assessors etc.)
- (i) Self Employed applicants (e.g. Consultants/ Surveyors/ Valuers/ Loss Assessors etc.) should have minimum gross total of individual annual income of Rs.15 lacs as reflected in ITR for any of the last 3 years from the date of applications.

VIII) The applicants working in Private organization will be eligible for Fellow (FIE) on satisfaction of the following condition:

His/her salary/compensation package should be Rs. 2 Lakhs per month as per Form 16/Income Tax Return as applicable [US\$ 3,000 per month or equivalent for applicants working abroad as per their self attested salary certificate/Form 16/ITR].

(IX) The income criteria for Retired applicants from private organizations whose income may be calculated by considering the inflation rate i.e., $\text{Calculated income} = (\text{Present Inflation index} / \text{Inflation index at the time of his retirement}) \times \text{Income at retirement}$.

N.B.

It has been observed that the Chartered Engineer certificate is often useful for the following purpose:-

- To be empaneled as Valuer, Loss Assessor in various financial institutions like Banks, Insurance companies etc.
- To be empaneled as Chartered Engineer in the Original Side of High Courts, Central Excise and Customs and other similar govt concerns.
- To win contract of civil works from Municipal Corporation and similar govt bodies.
- To have better opportunity of being employed and/or promoted in foreign companies.
- To practice as self employed consultant in India and abroad.

In general, the Chartered Engineer certificate being issued by the IEI, plays the role of recognition and acceptance of one's techno-academic qualification and professional attainment on a global platform.

6.0 Other Information

- Applicants residing in abroad must remit the fee in Equivalent INR.
